The average annual turnover for last three years should be over and above Rs 300 Lakhs.

The tenderer should have adequate machinery and technically qualified staff to carry out same type of work.

Necessary supporting documents, certificates and photographs of the work executed are essential and shall be submitted in envelope No. 01.
